DIRECTIONS TO THE TEST SITE

FROM EAST of Sturbridge: Route 90 (Mass Pike) West to Exit 9. Take exit 3B after toll onto Route 20 west. **At traffic light at intersection of route 131 and route 20 (at the Motel 8) travel 9.1 miles west on route 20. Take a right onto St. Clair Road and follow the road 1.5 miles up the hill from route 20. St Claire merges with Dunhamtown-Brimfield**

FROM WEST of Palmer: Route 90 (Mass Pike) East to Exit 8. Take a right at the light after the toll. At the next light take a left onto Route 20 east. (Brooke's Pharmacy will be on your right.) **Travel 5.7 miles on Route 20 east to St. Clair Road. Take a left onto St. Clair and follow the road 1.5 miles up the hill from route 20. St Claire merges with Dunhamtown-Brimfield.**

Travelling 84 East: Take route 84 East to Route 20 west in Sturbridge. See above *from east of Sturbridge.*
